

Dear Fellow Nobles,

The world has become a much smaller place. Shriners Hospitals for Children® has a global reputation for compassion and excellence, and continues to expand its efforts to reach as many children who may need the services of our unique health care system, regardless of where they live.

We have implemented an international strategic plan that will help us serve the children of the world more effectively and efficiently, and closer to their homes. Under the direction of Marjorie McEttrick-Maloney, RN, BSN, MPA/H, our chief nursing officer, and with guidance from a consultant, this plan streamlines our international services, and includes initiatives for many parts of the world, including Brazil, the Philippines,

Canada and Mexico. Today, I would like to share some exciting developments in our strategy for the children of Mexico.

Shriners Hospitals has had a presence in Tijuana, Mexico, for many years. From 1998 to 2012, we held outreach clinics at Hospital Infantil de las California (HIC). In 2012, we opened an ambulatory clinic adjacent to HIC. We recently moved our clinic to within Hospital Angeles in Tijuana in order to provide additional services, including inpatient and more complex surgical treatments. Today, that clinic, which is under the direction of our Pasadena, California, location, serves more than 10,000 children annually, providing orthopaedic surgical care and outpatient clinic visits, including orthotics and prosthetics services.

Based on our desire to increase our presence in Mexico, and the success of our clinic in Tijuana, we are pursuing discussions with Hospital Angeles officials to establish similar clinics at their locations in Guadalajara, Monterrey and Juarez, Mexico. If these clinics also are successful and meet our goals of reaching and caring for the children who need our expertise, we will have additional conversations with a goal of further expanding these efforts. Hospital Angeles has approximately 30 locations throughout Mexico, which could provide an opportunity for Shriners Hospitals to establish a network of affiliated clinics.

Obviously, there will be many details to work out, from staffing to space allotments, but the possibilities are tremendous – and fit well with the mission and goals of Shriners Hospitals for Children, especially as we seek to increase our affiliations and access points in order to reach and treat more children effectively, efficiently and closer to their homes.

An important part of our international strategic plan is including educational programs for local medical professionals in our outreach efforts. Ultimately, this will allow more children to receive care in their home countries, rather than needing to travel to the U.S. for care. Of course, we will always refer children to our facilities if that is the best course of action for them.

These are especially challenging times, as we work within the restrictions caused by the pandemic, but they are also exciting times with great promise for the future of our unique, compassionate health care system.

I look forward to sharing information about our strategic plans for other international locations in the future.

Shriners Hospitals for Children will be changing its' international brand to "Shriners Children's", however the new combined Houston and Galveston Hospital that will be located in Galveston will be a DBA "Shriners Hospitals for Children – Texas". The Houston hospital is scheduled to officially close Dec. 31, 2020, with the new SHC -TX scheduled to open January 18, 2021.

The Shriners Hospital system is spending \$45 million to combine these two historic facilities. According to Imperial Sir Jerry Gantt, President of Shriners Hospitals for Children, "this move is a commitment to transforming how our healthcare is delivered, while maintaining our mission of providing the highest quality of care to children with orthopedic, neuromusculoskeletal, cleft lip and palate and burns injuries". Shriners system just passed a \$921 million dollar budget for the 22 facilities in the system. The endowment for the entire system is approximately \$9 billion dollars.

Those attending the Imperial Session will be able to come to Galveston and tour the newest hospital in the system, Shriners Hospitals for Children – Texas.



My Fellow Nobles,

As I communicated to you on September 9, 2020, we need to assist our Brothers in Louisiana and Iowa. Both of these areas have been pummeled with natural disasters in the midst of a global pandemic, and they desperately need our help.

Louisiana has been devastated by Hurricane Laura. Habibi Shriners in Lake



Charles, Louisiana, took a large hit from the storm, but the temple is "fixable;" the same cannot be said for many blue lodges in the area. Many Masons in Louisiana have lost their homes and their lodges due to severe wind and water damage. The photos below show some of the damage that Habibi Shriners experienced.

At about the same time, sustained winds in excess of 100 mph caused enormous damage across a wide area in the State of Iowa. This derecho weather system has left many Iowa Masons and Shriners with significant personal losses. There is an immediate need to assist Masons and their families as a result of these storms.

The Grand Masters of the Grand Lodges of Louisiana and Iowa have requested assistance through the Masonic Service Association of North America (MSA) for disaster relief. In response, the MSA established a disaster relief fund for Louisiana and Iowa, with all donations received to be transferred directly to the Grand Lodges of Louisiana and Iowa for distribution to Brothers in need.

I have been in personal contact with each of the Grand Masters, and have pledged our support. Habibi Shriners has already provided men and materials to assist area lodges with remediation – let us all join them in providing relief.

You and I share a sacred obligation related to relief of a distressed worthy Brother. However, in



addition to just simply satisfying our Masonic obligations, our primary motivation should be the aspiration of Brotherly Love. Our actions, especially in times like these, will define for each of us what the word "Fraternity" means.
